The manufacturing of Possum's wide range of proprietary products has to date been carried out by British sub-contractors.

In future Nortec will trade as Nortec Solutions Limited and will remain a separate, independent company operating as a sister company to Possum under the common ownership of Eamont Holdings Limited. In addition, the manufacturing of Possum products will be moved over to Nortec over the course of approximately twelve months.
